## INTRODUCTION

The Secretary of Defense on Behalf of the Department of Defense of the United States of America, the Secretary of State for Defence of the United Kingdom of Great Britain and Northern Ireland, and the Ministry of Defense of the Government of the Republic of Italy, hereinafter referred to as the "Participants";

Recognizing the Memorandum of Understanding (MOU) of 28 August 1998, as amended 26 March 1999, between the Secretary of Defense on Behalf of the Department of Defense of the United States of America and the Secretary of State for Defence of the United Kingdom of Great Britain and Northern Ireland, for the Cooperation in the Engineering and Manufacturing Development (EMD) Phase of the U.S. Lightweight 155mm Howitzer (LW155) Program (the "LW155 EMD MOU");

Recognizing that work under this MOU will extend longer than originally planned and desirous to continue cooperation through the completion of this effort;

Recognizing that Paragraph 17.7. of the MOU provides that the MOU "may be extended by the mutual written consent of the Participants."

Have reached the following understandings:

### SECTION I PURPOSE

The purpose of the amendment is to extend the duration of this MOU by one additional year.

### SECTION II AMENDMENT

The LW155 EMD MOU is hereby amended as follows:

1. SECTION XVII (AMENDMENT, TERMINATION, ENTRY INTO EFFECT, AND DURATION), Paragraph 17.7., delete and replace with the following:

"17.7. This MOU, which consists of the Introduction, 17 Sections and two Annexes, will enter into effect from the date of the last signature and will remain in effect until March 31, 2005. It may be extended by the mutual written consent of the Participants."


SECTION III
