If this proposal is acceptable to the Republic of Slovenia, it is further proposed that this note, together with the Ministry's affirmative note of reply, shall constitute an agreement between the United States of America and the Republic of Slovenia, which shall enter into force upon the date on which the Slovenian side notifies the United States of America that all applicable procedures required for entry into force of this amendment have been fulfilled.

The Embassy also wishes to express the understanding of the United States of America that the provisions of the Agreement as a whole apply to radiological dispersal devices and radioactive materials, including but not limited to radioactive sources, suitable for use therein. The Embassy requests the Ministry of Foreign Affairs to confirm, in the Ministry's reply to this note, that the Republic of Slovenia shares this understanding.
